

## **PRIVACY POLICY**

### **1. GENERAL**

CHK Power Quality Pty Ltd (Business) respects your privacy and works hard to safeguard the privacy of your Internet activity. We created this privacy statement to demonstrate our firm commitment to the privacy of the users of our websites. ### **2. PERSONALLY IDENTIFIABLE INFORMATION**

The Business reserves the right however, to convey any information we collect from or about you to a successor-in-interest or business partner.

In accordance with the Federal Children's Online Privacy Protection Act of 1998 (COPPA), the Business will never knowingly request personally identifiable information from anyone under the age of 18 without first requesting verifiable parental consent.

### **5. COLLECTION OF INTERNET USAGE DATA**

The Business's network gathers information about Internet usage such as IP address information of users connecting to your site, IP address information of FTP transfers, number of e-mails sent, and data transfer usage.

### **6. SECURITY**
